This MoU has been agreed to promote academic cooperation and to encourage contact and cooperation of mutual interests between RUTS and USM.

1. The two universities will jointly develop academic cooperation to attain the goals of the following forms of activities:
 - a) Exchanging lecturers and students;
 - b) Conducting some scientific and academic activities;
 - c) Conducting research, seminars, training and workshop; and
 - d) Collaborating in publishing papers in international journals
2. RUTS and USM agree that specific conditions and details of implementation of any of the abovementioned activities are subject to specific agreements to be agreed upon between the two universities.
3. This MoU is a declaration of intent and does not legally or financially bind either of the parties hereto.
4. This MoU does not provide either of the parties a right to use the logo, trademark or name of the other party without its prior written consent.
5. The MoU will be in effect for three (3) years from the date of the last signature. This MoU may be renewed at the mutual agreement of RUTS and USM.
6. This MoU may be terminated by one of the universities, upon giving six (6) months prior written notice to the other university.
